**WHEREAS**, MIRDC declared a First and Second Failure of Biddings for the above-mentioned project under BAC Resolutions No. 2018-14 and 2018-17, respectively;

WHEREAS, the BAC invited contractors and posted the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS), MIRDC Website, and conspicuous places at the premises of DOST on June 26, 2018;

WHEREAS, no bidder attended the first Negotiation on July 16, 2018, 9 A.M., Mercury Conference Room, 3F MIRDC Gold Building, Bicutan, Taguig City;

WHEREAS, another date for Negotiation was posted on July 31, 2018 to which Pacific Summit Construction Group Inc. responded and submitted their bid offer on August 7, 2018;

WHERAS, Pacific Summit Construction Group Inc. passed the technical, financial requirements and the legal requirements;

WHEREAS, the BAC considered Pacific Summit Construction Group Inc. offer and decided to conduct post-qualification to verify and validate its submitted documents;

WHEREAS, after careful validation, verification and detailed evaluation of the bid of Pacific Summit Construction Group Inc. by the Technical Working Group, the team found Pacific Summit Construction Group Inc. to have passed the criteria for post-qualification and is responsive to the requirements and conditions for eligibility and the bidding of the contract as specified in the bidding documents;

WHEREAS, the BAC accepted Pacific Summit Construction Group Inc.'s bid proposal of Pesos Four Million Seven Hundred Forty Four Thousand One Hundred Twenty Seven Pesos 30/100 (Php 4,744,127.30) and considered it as the Best and Final Offer;

  - (i) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;

- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
