INVITATION TO BID

“ESTABLISHMENT OF A GEAR MAKING AND ASSEMBLY FACILITY”

1. The METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER, through the project “ESTABLISHMENT OF A GEAR MAKING AND ASSEMBLY FACILITY” intends to apply the sum of Eighty Seven Million Three Hundred Thousand Pesos and 00/100 (Php87,300,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for *the procurement of the following equipment*, inclusive of taxes, fees, delivery costs and other incidental charges, in payment for the supply and delivery of the following items particularly described as follows:

2. The METALS INDUSTRY RESEARCH AND DEVELOPMENT CENTER now invites bids for the procurement of the following items listed below located at MIRDC Compound, Gen. Santos Ave., Bicutan, Taguig City. The required delivery period is:

3. Bidders should have completed, within *Two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
5. For Goods, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. For Infrastructure, Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines
7. Interested bidders may obtain further information from Ms. Katherine T. Llanto/Omaira A. Grande, BAC Secretariat, MIRDC and inspect the Bidding Documents at the address given below during 9:00AM to 4:00PM. A complete set of Bidding Documents may be acquired by interested Bidders on February 24, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB, in the amount as specified below:
